- Perform, schedule, and witness inspections and testing, monitoring construction activities and documenting results
- Effectively and continually prioritize the task at hand to ensure timely and compliant completion of the testing and documentation
- Check contractor's work for quality and specification compliance
- Identify and resolve complex quality-related issues in the field
- Coordinate inspection activities with contractor, other inspectors, regulatory agencies, and/or internal departments on quality related matters
